"There are times – if you believe in the right of protest and demonstration – that you have to show this." –Vel Phillips, elected official, lawyer, judge, fair housing activist in Milwaukee

There are not many who can match the number of "firsts" of Vel Phillips.

First African American woman to graduate from UW-Madison law school.

First African American and first female Secretary of State in Wisconsin.

First African American judge in the state of Wisconsin.

First female judge in Milwaukee County.

First African American and first female alderperson elected to the Milwaukee Common Council.

That is truly a life of firsts. As a champion of fair housing in Milwaukee, a city known for its systematic segregation and inequality in housing, Vel Phillips followed the path of lawyer and elected representative to have an impact on these issues. It was how she was determined to make change. She proposed her Fair Housing Law in 1962. The law would make it illegal not to rent to black people. But it was voted down. Again. And again. For 6 long years. And Vel Phillips took a new path of "first". Talking was not enough so she began to march and participate in non-violent protests against discrimination. *There was a time to show this.* They and many peaceful protesters endured bottles and rocks thrown at them because they were working for change. They showed up for 200 nights. Vel was arrested. People began to pay attention. *There was a time to show this.*

AAUW has a long standing policy of promoting the economic, social and physical wellbeing of all persons. This includes "reduction of poverty, a living wage, paid family and medical leave, safe and affordable housing, a clean environment, recognizing that gun violence is a public health crisis", and more. (*AAUW Public Policy Priorities, 2017-19*) I picture our organization as a giant march, a giant peaceful protest, and a truly a giant voice that for 130 years has worked to bring change and make an impact for good. I like to imagine that Vel Phillips would have been a member of AAUW-Appleton Branch if she had lived in our community. She would have been writing representatives during meetings to give voice to those who need our support. She would have come to branch meetings that inform and educate. She would be lugging books to give someone a scholarship and she would be cheering us for all the courageous "firsts" we do in our own lives.

Let's show everyone how great we are! Let's show up and use our collective voice!
