"They shoot to kill when it comes to cattle thieves in Illinois, and fish and fowl are safeguarded by stringent game laws – but womenfolk come cheap." – Mary Doty, reporter, Chicago Daily Times, 1936

If you are looking for a book to read while just out of foot surgery, I recommend *The Radium Girls* by Kate Moore. Because just when you are starting to whine about the discomfort of pins in your toes and the inconvenience of the dang boot...you read about the "shining" women and your problems seem very small. The book is the story of the dial painters of the late 1920's who painted luminous radium on watch faces. And they dipped their brushes in the radium, then in their mouths to fine tune the points. Every day. Lip – dip – paint. Hundreds of young girls work in these studios "amid the glowing dust of the radium factories" – until they begin to fall shockingly ill. Their teeth fall out, their jaw bones break and pieces break off into their mouths, their hips and knees develop rapidly growing tumors, their bones glow eerily in the dark and they die in their 20's. But the most horrific part of this story is the fact that the employers knew of the dangers and systematically kept these facts hidden from the girls. The companies even hired their own doctors to declare the girl's healthy, state that radium was safe, and suggest the girls had come to work already in poor health. One girl's death certificate: *syphilis*.

As you can imagine, this story is a drawn out legal nightmare for these brave women. And sets the stage for safer workplace conditions in the years to come. But...

How do we currently stand on issues for women in the workplace? Of course there is not lip pointing anymore. But according to the most recent study by AAUW, *Limiting Our Livelihoods*, "Workplace sexual harassment can take a toll on women's physical and mental health, limit their job choices, reduce the prospects for career development and even force them out of the workforce." It is ironic that just as the radium collected in the girls' bones and gradually forced them out of jobs and showed up years later as horrible physical ailments, this study reports that "these negative effects [of sexual harassment] compound over time, reducing women's lifetime earnings and contributing to both the gender and retirement wage gaps." Not only that, but "studies show that the destructive impact of sexual harassment on a woman's health and well-being can last for years after the incidents." You probably have seen the latest about McDonald's being sued for systematic sexual harassment of female workers. 1920, 2020...have we really changed?

AAUW again has shown, through this recent study, what is unique and remarkable about our organization. Research. Data. Facts. If you are snug and snowbound or recovering from too much beach time in the next few months...check it out on aauw.org.

All people living in the United States, Puerto Rico, American Samoa, Commonwealth of the Northern Mariana Islands, Guam, and the U.S. Virgin Islands are required by law to be counted in the 2020 census.

Strict federal law protects your census responses. It is against the law for any Census Bureau employee to disclose or publish any census information that identifies an individual. Census Bureau employees take a lifelong pledge of confidentiality to handle data responsibly and keep respondents information private. The penalty for wrongful disclosure is a fine of up to \$250,000 or imprisonment for up to 5 years, or both.





MISSING AND MURDERED Indigenous Women & Girls

The Problem:

Violence and homicide affect Indigenous women and girls at highly disproportionate rates to other American women and children. The systemic causes of this violence is not clearly understood.

Indigenous women also go missing at disproportionate rates. Discrepancies exist within national and state databases which are not regularly or accurately updated with information on missing Indigenous persons.

A number of jurisdictional barriers between state and tribal law enforcement has caused cases to go unsolved. Cases that are not accurately tracked rarely brings the perpetrators to justice.

Widespread data gaps means that current numbers on missing and murdered Indigenous women are under-reported. These practices make Indigenous women and girls even more vulnerable to violence.

The Solution:

The crisis affecting Indigenous women and girls warrants a thorough investigation.

AB 548 / SB 493

A Wisconsin bill for a task force is in the Assembly and Senate committees.

Ask your legislator to sign on and request a public committee hearing

An investigative task force should be composed of a mix of tribal leaders, survivors of gender violence, missing persons experts, law enforcement and other experts.

The task force should examine factors contributing to violence, homicides and disappearances suffered by Indigenous women.
