I felt the sensation of a collective gasp of "oh no!" on that September day when Ruth died. And then the emptiness that followed. What was it about this tiny woman that had such an impact on each of us? Maybe it was the fact that she graduated at the top of her class and became one of nine women (out of 500 enrolled) at Harvard Law School. Or perhaps the fact that she co-founded the *Women's Rights Law Reporter* (the first journal about women's rights) and she fought for her female colleagues to earn the same retirement benefits as her male counterparts at Columbia Law School. Maybe her impact was her tireless advocacy for gender equity and her resolve to fight sexbased discrimination. That certainly resonates with AAUW members.

But I think it is more than this.

When I see RBG as a young woman it is startling. Her image in my head is "old". My age and beyond. Her impact on me is that she worked and advocated and fought for what is right and did it in her later years. She was...in many ways...us. She knew it was tough to raise a child while working. Exhausting. She understood that sometimes life takes turns we never expect, as she buckled down to take school notes for her husband while he had cancer. The loneliness of caretaking. Her fictional hero as a girl was Nancy Drew. Of course. Who else?? She moved for her husband's job. A common experience for women. She worked through her own sickness and inspired us with push-ups. Ok. Ok. I will get out and walk. Our lives often take similar turns and we can certainly look to her for inspiration to trudge onward.

Many of us in AAUW who are "trending older" can hear Ruth urging us to keep at it. She is reminding us that age is no excuse and we need to inspire others to action, to take on leadership, dissent when we see injustice. We can all be those who fight for what is right and we can do it in AAUW...and in a way others want to join us.

Ruth said in 2017 "It's hard to do anything alone. But get together with like-minded people, join organizations." We are that organization...not like-minded in every way, but certainly united in our mission to advance gender equity and work for social justice. We can get things done by being together. And we know that after the election our work continues.







#### **Dear AAUW-Appleton Members:**

I am writing to ask for your help in advocating for Appleton Public Library building project. These next two weeks will be critical in deciding whether the library building project moves forward.

As you probably already know, the Mayor recently announced his plan to renovate or replace the library building at its current location of 225 N. Oneida Street.

Mayor Woodford released his proposed budget for 2021. In it he has set aside \$2.4 million in capital expenditures for the planning and design of the new library building. Shortly, Common Council will be convening to discuss and vote on the proposed budget. Here are the dates to keep in mind:

- Saturday, October 31<sup>st</sup> is Budget Saturday where the Mayor presents the budget to Finance Committee for their review and vote.
- Wednesday, November 4<sup>th</sup> at 6pm is Budget Public Hearing. The whole Council will hear public statements about the budget that the Finance Committee approved.
- Wednesday, November 11<sup>th</sup> at 6pm is Budget Adoption. The Council discusses the entire budget including any amendments submitted by Alderpersons and votes to approve it.

The Friends needs your help in advocating for the proposed capital expenditure for the new Appleton Public Library building!!

Please contact your Alderperson and let them know you support the new library building project and the capital expenditure of \$2.4 million in the proposed budget. The Alderpersons will absolutely be hearing from constituents who are against the new library building so it is <u>imperative they also hear from library supporters</u>.

It is also important to keep in mind that it is more effective to contact your Alderperson specifically as opposed to all Alderpersons. Your Alderperson is responsible to you as a constituent. It is also easier to ignore group emails than personal, direct emails or phone calls.
