AAUW National News—Membership Dues

What's happening: As a valued member leader of AAUW, I wanted to let you know that the AAUW Board approved a modest dues adjustment — $\frac{$2 \text{ per year over the next two years}}{}$.

New national dues: \$74 starting April 1, 2025, and \$76 starting April 1, 2026.

Why it matters: Member dues are an important funding source for AAUW. While costs for member support increase annually, dues have not kept pace. During the feedback process, we heard from more than 750 members. The Board's decision to increase dues by \$2 reflects an adjustment to the original proposal to lessen the burden of a dues increase on members while keeping pace with inflation.

Your member dues help fund member services such as:

- **Administrative Support:** Assist with dues processing, Community Hub management, 990N filings, branding materials, and toolkits (e.g., DEI Toolkit, College/University Member Toolkit).
- **Website Support:** Update and manage ~500 branch and state websites and provide ongoing Site Resources support.
- Member Trainings: Hold regular virtual member gatherings and training programs.
- **Member Engagement:** Organize member-led groups and committees like Archives Corps, Lobby Corps, and national committees.
- Speaker Engagement: Offer National speakers for branch meetings and state conventions.
- **Real-Time Support:** Connect Team provides daily assistance and semi-weekly "Office Hours" for member leaders.
- And more!

The bottom line: We heard you. The dues increase balances AAUW's financial sustainability with the member feedback we received. Thank you for being an engaged leader!



The following 2 Resolutions will be presented and voted on during the business meeting at convention.

Proposed AAUW Wisconsin Resolution Upholding the Civil Rights of Americans who Identify as LGBTQ+

Whereas, AAUW Public Policy Priorities advocate for freedom in definition of self and family, including protection from discrimination and a guarantee of civil rights for all family structures, and

Whereas, for too long the civil rights protections guaranteed to millions of Americans have been denied to those who identify as LGBTQ+ (lesbian, gay, bisexual, transgender, queer or questioning, and those identities who may not fit into the acronym), and

Whereas, no one shall be denied the full range of civil rights and liberties due to their sexual orientation or gender identity, and

Whereas, AAUW WI has the privilege and responsibility to acknowledge and uphold these principles for all citizens of Wisconsin, and

Whereas, unless and until LGBTQ+ people are able to enjoy the same rights and freedoms as their fellow Americans, the nation's promise of equal justice under the law will remain unfilled, and

Therefore, be it resolved that AAUW WI will advocate for the full range of civil rights and liberties for all who identify as LGBTQ+. Such rights and liberties include freedom from discrimination in schools and the workplace, the guarantee of spousal/partner benefits – including the ability to care for dependent children, the ability to serve one's country in uniform, and the ability to serve as an elected official of the government

Proposed AAUW Wisconsin Resolution Constitutional Amendment to Eliminate Big Money in Politics

Whereas, AAUW National Public Policy Priorities oppose all forms of discrimination and support constitutional protection for the civil rights of all individuals, and

Whereas, AAUW National and AAUW WI both believe that AAUW must advocate for equity, individual rights, and social justice for a diverse society, and

Whereas, AAUW WI recognizes an obligation to advocate for campaign finance reform that will promote equitable representation and equitable participation, and

Whereas, AAUW WI believes free and fair elections are essential to democracy and effective self-governance, and

Whereas, interpretation of the U.S. Constitution by appointed Supreme Court Justices included corporations in the term "persons," and

Whereas, in the 1976 Buckley v. Valeo ruling, the Supreme Court changed the course of American elections and established the doctrine that spending money to influence elections is a form of speech, and, Whereas, on January 21, 2010, in Citizens United v. Federal Election Commission, the Supreme Court overturned a century of precedence by ruling that corporate spending on elections cannot be limited under the First Amendment, and

Whereas, AAUW WI believes the above decisions (i.e., allowing corporations to act as persons to influence politics, that spending money is a form of speech, and allowing unlimited spending by corporations and wealthy donors) lead to the diminishing rights of individuals and inequitable * representation in elections, and

Whereas, AAUW WI members recognize the need to engage in constructive acts to make a meaningful difference towards societal change, and

Therefore, be it resolved that AAUW WI will pledge to seek to reclaim democracy from the corrupting influence of unlimited political contributions and spending by standing with women across the country to support passage of an amendment to the United States Constitution stating: 1) Only human beings are endowed with constitutional rights – not corporations, unions, nonprofits or other artificial entities; and 2) Money is not speech, therefore limiting political contributions and spending is not equivalent to limiting speech.

Note: We added a footnote at the bottom that is missing from all saved copies. * Inequitable actions or situations are those considered unjust or unfair, often viewed through a lens of moral or ethical judgment. This term suggests a deviation from what is right or just in a societal context, where the focus is on the fairness of outcomes or processes. On the other hand, unequitable pertains to the absence of equality or equity, primarily in terms of distribution or allocation. It indicates a scenario where resources, opportunities, or rights are not distributed evenly, but it does not necessarily carry a moral judgment.

Additional information is on the JFC <u>website</u>. If you plan to speak in person, prepare a two-minute testimony. Be sure to leave a copy of your comments when you sign in. The lineup of people wishing to speak is usually long so your wait may be several hours.

Contact members of the <u>JFC</u> as well as your Senate and Assembly <u>representatives</u>.

Tell them: "1. Raise the low revenue limit \$1000. 2. Raise the per pupil revenue limit to at least \$450 each year of the budget and tie future increases to inflation. 2. Raise the special education reimbursement rate to at least 60%. 3. Increase mental health funding to a minimum of \$250 million. 4. Fortify our schools against Federal cuts."

Info for you: Public schools have not been funded enough to cover inflationary increases for the past 16 years. Most districts have to rely on referenda every few years and also dip in their reserve fund. Neither is a reliable funding source. This has created a great disparity among districts across the state.

THE K-12 SUPPORT OF THE U.S. DEPARTMENT OF EDUCATION IS BEING THREATENED!

- Contact Senator Baldwin, Senator Johnson, and your member of Congress.
- Tell them: "DO NOT cut the Department of Education, its funding, or its oversight powers."
- **Info for you:** Wisconsin's 421 K-12 school districts receive 8-10% of their annual budget from the federal government. The Department of Education (DOE) distributes the funds for after-school activities, early education programs, lunch subsidies, special needs services, and more. In addition, the DOE enforces the laws that protect students against discrimination.

Without the Department of Education, K12 education is threatened. Federal funding may be cut altogether, or it may be sent to the states as block grants, perhaps for vouchers and independent charters. The privatization of public schools will result in greater disparity in educational opportunities as well as ideological driven curriculums.

<u>Individuals with Disability Education Act</u> funding, now implemented and regulated by the Education Department, would go to states with no strings attached as per Project 2025. Before IDEA, students with the most severe disabilities were institutionalized or not educated at all. Students with milder disabilities were ignored or put in "slow classes." In some states, those days would return.

<u>Title I funding</u>, which helps level the playing field for schools with large proportions of high-needs students, would be distributed without department regulation at the whim of state politicians. Funding would eventually be eliminated, according to Project 2025.

Without the Education Department's extensive data collection through its <u>National Center of Education Statistics</u> and <u>Office for Civil Rights</u>, researchers would not have access to the data they need to compare states and their outcomes.

Without the department's Office of the Inspector General, there would be no federal agency for parents and teachers to register serious violations of students' rights and know they will get the investigation they deserve.

Letter to the Editor:

Voters have important choices in the upcoming statewide election April 1. The American Association of University Women-Appleton, would like to alert voters to the referendum question on the ballot. This latest effort to re-write the constitution offers a real threat to Wisconsin women.

The current Wisconsin Voter ID law is strong. That law came about by the democratic method of listening to constituents, crafting legislation that had to pass two houses, and then be signed by the governor. This is a thoughtful process with many opportunities to fine-tune the document.

What this April referendum question seeks to do is insert our current photo ID law into the constitution, not because there is a problem with administering it, but because someone is determined to enshrine it forever. Modernizing the system or meeting new needs would be nearly impossible. In many cases, voters will evaluate the proposal with only a few seconds to decide as they complete their ballots. Recent questions have not been widely understood or discussed by voters and are not easy to comprehend at first glance. This is not the thoughtful review that constitutional change should have.

Secondly, the referendum directs the legislature to pass laws determining what constitutes a valid photo ID, and what documents are acceptable as proof of name. This is where problems for women voters begin. A high percentage of female voters do not have a photo ID name that matches their birth certificate because they assumed their husband's name at marriage, and many do not have a passport. Others cannot access their wedding certificates to explain why their name at birth isn't their current name. The roadblocks and delays would be frustrating, perhaps deterring. Men would not face this challenge.

Another group of citizens who is threatened by this proposal is the "indefinitely confined." Currently the law allows people who have that status to vote without trips to polling places to show their photo ID each election. Military members serving overseas are exempt from producing a photo ID. Our current law is thorough yet humane.

This will be a close election. Learn about the issues. Your vote will make a difference!
